TREASURER'S REPORT

• Stephen Anderson indicated expenses are under and we may still have some expenses coming in from the transition

MANAGING AGENT'S REPORT

Insurance check has been received from recent flood. The front desk is still accepting
auto draft forms for any homeowners that want to set up automatic withdraws every
month for their monthly assessment.

CLUBHOUSE MANAGER'S REPORT

- Wrought iron railing for front fountain scheduled for installation 10/26/2017
- Projector appears to be working
- Refrigerator in the Annex is out
- Handicap spaces in front of clubhouse are complete and maintenance is continuing to work on the red fire lanes.
- Brinkman Roofing is coming out on 10/31/2017 to look at the roof.
- Contacted company who originally installed the river pump. He is scheduled to come out and if unable to fix the pump a new one will cost \$5,600.
- · Received bid back for power washing North and South Riviera
- ProMaxima is scheduled to come out to repair treadmills
- Pearland Community band director asked if they could use the ballroom stage on Tuesday nights for rehearsal.

COMMITTEE REPORTS

Landscape Committee, Diane Nicolas

- Upon a motion duly made and seconded, the proposal from Maldonado for drainage/grading issue at the clubhouse in the amount of \$4,800 was approved pending the facilities committee in agreement.
- The Landscape Committee is still reviewing bids for landscape at the clubhouse.

Facilities Committee, Rex Hemme

• The following items have been completed: replace pool heater, study the source of the leak under the pool deck, clean the bottom of the spa will be done in December as it has to be drained, replace backup batteries on the controller on the middle two front gates, and replacement installation for the curved fences in front of the clubhouse will be replaced on 10/26/2017.

• There are roughly 32 spots that needs to be repaired on the curbs.

Finance Subcommittee, Joe Dekunder

- Joe Dekunder stated Tommy Johnson are new to the committee.
- 2018 Budget has been submitted
- Received insurance quote from BCH from Severn Trent. Going to look into getting additional bids.
- 2016 tax return hasn't been filed and its currently being worked on
- Briefly went over the MUD will be handing over all repairs/maintenance to pond areas and we need to be prepared.

Clubhouse Subcommittee, Mike Sanders

- Mike Sanders indicated there was a homeowner concern about the possibility of putting a recycle bin in the kitchen.
- Have received positive feedback in regards to the dedicated handicap parking spots
- Pointed out a few sections to review in the rules/regs

Contracts Subcommittee, Fritz Ring

- Fritz King stated the Maldonado contract has been signed.
- There will be a meeting with Maldonado and the Landscape Committee to discuss the transition.

ADDITIONAL BUSINESS

MUD #18, Bill Burdick

- MUD meeting on October 24, 2017.
- There should be no increase in the rate for taxes.
- MUD will be using our facility for their upcoming meeting in November and December.

Villas Master, Bill Burdick

- The Villas Master approved their 2018 budget and for BellaVita will be around \$44k per year.
- The Villas Master Annual Meeting will be in March 2018.

Homeowner Concern Forms, Billy Potter

- A concern was mentioned that the streets are dirty and need to be addressed
- A concern about the treadmills being broken
- A concern was brought up in regards to the chain link fence we put up
