MESSAGE FROM THE HOA BOARD PRESIDENT - RUTH SOUTHARD

2015 will be the thirteenth Christmas in BellaVita for me and my husband. Typically, 13 marks a new phase of growth (teenage years) and that is true of your HOA. The organization structure is sound and the committees have a maturity that enables them, as well as the board, to operate more effectively. This operation is also due to the commitments of so many capable homeowners.

The committees, along with the Clubhouse staff, assist the Board with the various functions of the HOA. As we begin a new year, I would encourage you to review the various opportunities for service to the community. Resolve to become involved in 2016. Almost every club, committee, and/or Task Force would welcome new members.



A new opportunity will be presenting itself in January 2016. The current contract with Comcast is due to expire in 2018. This contract represents more than \$350,000 (or 25%) of the annual operating budget. We expect to see some amount of changes to this contract. The Board will be approving the appointment of a Task Force to review the contract, survey the homeowner needs, investigate options, and propose a solution. We are looking for homeowners interested in serving on this task force. It will be an 18-month commitment. Contact the HOA President for more information.

In addition, road construction could begin as soon as January as West Development is proceeding with the plan to add homes at the end of Berlino.

As the year winds down, we see closure to several major projects and renewal of ongoing tasks. The 2016 budget was approved with no increase in the monthly assessment. There is a small deficit in the operating budget due, in part, to the Board's decision to aggressively pay back the fence loan over the next two years. There is no need for alarm at this point because of the operating surplus that accrued over the last several years. The fact remains that the budget is tight and changes may be required in the next couple of years. A very conservative Strategic Plan 2016-2021 was approved providing a roadmap for the organization. New legislation impacting HOAs was passed in Austin and has been integrated into our procedures.

As the lights glow and decorations abound, we are reminded, once again, what a lovely community this is.

2015 legislative changes to Property Code 209.0058 still requires Ballots be signed in an election to fill seats on Board of Directors. Sec. 209.0056 requires at least 20 days from date of mailing of the Ballots to the date that Ballots are due. We have changed time frame for the mailing dates to accommodate this change.


Sec. 209.0058 added the following provision: "each candidate may name one person to observe the counting of the ballots, provided that it does not entitle this observer to see the name of the person casting the ballot and also provides for the removal of any disruptive observer".

Please mark your calendars for these dates and be sure to read the letters and accompanying documents as they are received. If you are interested in serving on the Board, please make plans to attend the Candidate Orientation. This program is held to introduce anyone interested in serving on the Board to the duties, responsibilities and commitment required to serve in this capacity. The Orientation is open to all residents of BellaVita. Your vote is extremely important as well as you decision to serve.

FINANCE COMMITTEE

The 2016 Budget has been drafted by the Finance Committee and accepted by the Board of Directors. It will be distributed to homeowners by FSR when the 2016 assessment coupons are mailed.

The budget shows no increase in dues, but it does include a small deficit, as did the 2015 budget. While existing retained earnings are easily sufficient to cover the projected deficit, this cannot continue indefinitely.

As most homeowners know, the subdivision is now built out. That means there is no steady increase in the overall dues base as there was in years past. From now until eternity, we face the same budget battles of any other group. We need to balance our desire to hold down dues with the need to provide amenities that make BellaVita a very desirable place to live.

To that end, the Board and the Finance Committee would welcome input from all homeowners as to what is important and what is not, what is necessary and what is not.

Amenities such as lawn service assure a uniform appearance throughout the subdivision and help support high property values. Amenities such as cable TV are of great importance to some, while others don't even use Comcast at all. The Board will establish a committee to research that issue but the current contract is in place until 2018, so no change will happen soon. Homeowners will be surveyed in 2016 to help set priorities for amenities and to assess feelings about a dues increase. To make the survey effective, please feel free to contact any of the Board members or Finance Committee members to be sure that subjects of high interest to you are covered in the survey.

ADDITIONAL FENCE OPTIONS MIGHT BE AVAILABLE--ACT NOW!!

Rockin' D Fencing has agreed to consider doing additional fence work after the primary Fence Replacement Program is completed provided there is sufficient interest on the part of Homeowners.

This work would involve:

- replacing existing wood gates at "emergency exits" on the sides of houses;
- -- adding "caps" along the top of wood gates identical in appearance to the "caps" on wood fences facing streets.

This additional work would be at the Homeowner's expense. Homeowners interested in either of these projects should send an email to: fencetf@club-bellavita.org. or sign up at the Clubhouse ASAP but no later than December 15. This is a solicitation of interest to provide Rockin' D a general idea of the amount of work that might be requested. Firm prices will be determined by the contractor later. At that time Homeowners can make their decisions.

NOTE: In the meantime Homeowners are discouraged from adding "caps" to their gates on their own. Doing so could possibly void the warranty on their gates.

Frequently asked Questions about Yard Maintenance

1. Does the HOA replace my grass if it dies?

It is the homeowner's responsibility to monitor and maintain their yard in accordance with the ARC Guidelines. The HOA will not replace or repair damage to grass or plants.

2. How often is my front yard mowed?

During the summer months, front yards are mowed 4 times a month.

This winter, tentative dates for mowing the front yards are: Dec. 7 – 11; Jan. 8 – 12, 18 – 22; Feb. 1 – 5, 15 - 19; March 1st, 3rd and 4th weeks

3. Does the HOA pay for trimming my trees?

No, trees are the homeowner's responsibility. Crepe myrtles are trimmed only if they do not extend beyond the roof line.

Trees that overhang into the street are the responsibility of the homeowner.

4. How often is my front yard fertilized?

Front yards are fertilized 2-3 times a year as the weather and vegetation conditions warrant. The fertilizers also treat weeds, insects and disease.

Treatment does not quarantee success.

5. Does the HOA maintain the homeowner's irrigation system?

Your HOA dues include routine maintenance of the original system in the front and back yard:

- Sprinkler head adjustments
- Repair of sprinkler heads
- Controllers

6. What does your HOA NOT cover on the irrigation system:

Instructing or training residents on their systems – residents are responsible for setting and monitoring their own control box.

Modifications or additions to your original system.


Repairs to your system as a result of negligence, weather related occurrence, subsidence etc.


