s we approach the busy holiday season, may we consider how fortunate we are to be part of a community like BellaVita -- where people make the difference. It is truly amazing how many people serve unselfishly to maintain the quality of life for all of us.

During the summer one homeowner had an idea regarding the maintenance of the wrought iron fences around the pool. The concept worked and, while it is not fully complete, the method for repair saved the association tens of thousands of dollars.

Another group has been working steadily on the front gates. BellaVita is a beta site for the latest generation of call box. The efficiency of the system was dependent on upgrading the "clickers". Be sure to read the articles in this issue about the gates and the clicker exchange.

The Finance Committee worked diligently to produce a revised Reserve Study so we can plan for future expenses. In addition, they successfully prepared the 2014 operating and capital budgets with the directive that there be no increase in assessment. The approved budget was hand-delivered to each home in mid-November.

The issue of traffic management was resolved (See article) and the speed limit will remain unchanged.

Early in October, the City of Pearland invited Homeowner Association Board members to attend the first of the planned quarterly meetings. Benny Frank and I attended this meeting. We were introduced to the various departments and the functions of each. The city hopes to use this as a means of better communicating with the neighborhoods.

In January we begin the process of conducting an election for board members. Be sure to read the article containing the timeline for this event and watch for additional announcements in the Daily News and the Weekly Announcements. There is also a separate tab on the website specifically dedicated to Elections. Board members are elected and charged with operating the corporation for the benefit of the whole community. Voting for the members of the Board of Directors is your way of providing input to the decision-making process. Exercising your right to vote for the open positions is especially important in 2014 since a majority of the positions will be on the ballot. I would encourage some of you to consider running for the board. Please do not hesitate to contact any board member for information that might be useful to you in making this important decision.

Traffic Enforcement Voted Down

At the Board of Directors meeting on September 25, a motion was made and passed to NOT allow the City of Pearland to enforce traffic laws in BellaVita. BellaVita will remain the authority for traffic management in the community.

The Board followed the procedure outlined in the September issue of the BUZZ. The second reading of the ordinance did pass the City Council on August 12.

The Board of Directors discussed this issue at a workshop on September 18. Many homeowners participated by attending the homeowner forum where this issue had been presented, contacting board members personally, and submitting questions and concerns in writing. In addition, the following questions were raised and considered:

- Do we have data supporting changes? Have there been any accidents or near misses?
- Do we have any documentation of traffic violations?
- How many frequent violators do we have?
- What would be the effect of raising speed limit?
- What effect could there be to bikers/walkers/golf carts?
- Risk to self-government
- Risk of future regulation changes by City
- Will it be effective in curbing speeding stop sign running? How much time can the city police actually be here to patrol?
- Undesirable exposure of residents to fines.
 Are we punishing the majority of homeowners for the inability of a few to follow the rules?
- · Is there any liability if we do not implement?
- Are costs justified? Do the STOP signs really need to be larger and mounted higher to be effective? When the size changes in the future will BellaVita be required to change them again?
- Could sidewalks be required by the city throughout BV?
- Are there better, less drastic alternatives?

Of all of the considerations, the most important issue was forfeiting our ability to self-govern. This is a privilege that the Board believed should be protected above all others. BellaVita is a safe, desirable community in which to live. Introducing outside agencies to enforce existing laws (as well as any new laws developed in the future) would result in a loss of control that could dramatically harm the quality of life we have come to enjoy.

It should be noted that the City has enforcement capability for handicap parking and reckless driving at all times and has issued citations and warnings in the past to BV residents.

It Takes Everyone to Keep Our Neighborhood Beautiful

- During the cooler months, the grass only needs to be watered once a week for 10 minutes. This will minimize the appearance of brown patch, which is a fungus and still keep your yard healthy.
- Mulch will be distributed to every front yard starting in January. There will be a sign-up sheet at the clubhouse, if you do not want mulch.
- Continue calling FSR, not Rusticscapes for any work orders pertaining to vegetation in the front yard. This includes trimming of bushes and hedges, spraying ant mounds and weeding. Rusticscapes will not trim flowering bushes unless there is a work order. (except crepe myrtles) The HOA does not pay for the trimming of trees or palm trees in residential yards.
- Call FSR for irrigation problems in both back and front yards and have FSR generate a service request. The HOA pays for certain repairs. The homeowner is free to contract any company to repair irrigation problems not covered by the HOA.
- The schedule for mowing during the winter/spring is:

November: 2 times February: 2 times
December: 2 times March: 3 times
January: 2 times April: 4 times

Fertilizer will be applied to the front yards in March, 2014.
 A combination fertilizer, insecticide and fungicide will be applied to the front yards in May, 2014.

Signs will be posted indicating watering needs after the application.

- Always request the service order number from FSR when requesting a work order. This will make it easier for you to track your service request.
- Do not dump trash in the nature reserve. Plant clippings can be scattered in the nature reserve as long as it is not on or near the nature trail.
- If you have a drain opening in the back and front yard, it should be checked for obstruction several times a year.
